MEDICO-LEGAL PRACTICE


- Dr Baggaley has a busy medico-legal practice and he receives approximately 12 instructions a month, of which 60% are claimant, 45% defendant and 5% joint.
- His practice includes Personal Injury, Clinical Negligence, Immigration matters and Employment Law. He has a particular experience expertise in Military matters, Aviation issues, psychosexual issues and psychiatric serious incidents. He provides expert reports for the General Medical Council and other regulatory bodies.
- Dr Baggaley attends Court to give evidence in person on average three to four times a year.

CLINICAL NEGLIGENCE WORK.

- Dr Baggaley has been doing clinical negligence work since 1995.
- Approximately 30% of his medico-legal practice is medical negligence so he sees around 50 cases a year.

EXPERIENCE

- Dr Baggaley qualified from St Bartholomew's Hospital in 1984.
- He served in the British Army from 1985 until 1997.
- He trained as a psychiatrist in the Army and at Guy's Hospital London.
- He has been a full-time psychiatrist from 1986 and has been a consultant psychiatrist from 1993.
- He worked as Senior lecturer in Military Psychiatry for 4 years and for two years was Head of Division at the Defence Services Psychiatric Centre, Catterick.
- He left the Army and was appointed to the post of consultant psychiatrist for the Lewisham & Guys Mental Health Trust and senior lecturer in psychiatry for the Guy's, King's College and St Thomas's Hospitals' Medical and Dental School in 1997. (Lewisham & Guys became the South London & Maudsley NHS Trust in 1999.)
- He was Clinical Director for Lewisham from 1998 until 2007.
- He was Executive Medical Director of the South London & Maudsley NHS Foundation Trust from August 07 to September 16
- He was appointed Chief Medical Officer for Maudsley Health, responsible for the Maudsley Hospital clinical operations in the UAE in October 2016. He returned to the UK full time in July 2019 to work in an independent private practice from his rooms near London Bridge.
- He remains active clinically, retains a licence to practice and is approved under Section 12(2).







CLINICAL EXPERTISE.

- He has extensive experience in the assessment, treatment and management of post-traumatic stress reactions and the management of psychological trauma after accidents and disasters.
- Whilst at Catterick, he was in charge of the Post Traumatic Stress Disorder (PTSD) programme, specialising in the management of treatment resistant PTSD. He has served on operational tours in Bosnia and Northern Ireland.
- He has seen and treated victims of the military campaigns of WW11, Korea, the Congo, Northern Ireland, the Falklands, the Gulf War, Bosnia, Iraq and Afghanistan. In addition, he has seen and treated victims of civilian accidents such as the M1 air disaster, Lockerbie, Hillsborough, the Zeebrugge Ferry, from road traffic accident and assaults.
- Dr Baggaley has a particular interest in traumatic stress reactions. He has been involved in the assessment and treatment of both traumatic and work-related stress.
- He continues to be active clinically and treats private patients and assesses medicolegal cases in his private rooms near London Bridge.
- Dr Baggaley worked in and then ran for a number of years a specialised psychosexual clinic at firstly at Guys Hospital and then the Maudsley Hospital.
- Dr Baggaley is listed among the government's list of doctors and psychologists specializing in gender dysphoria.
