



 of Commons Veterans in the Criminal Justice System Group (2010-14).







- I was a member of the Scottish Trauma Advisory Group from 2010 to 2019 advising Government Policy Makers and commissioners about Traumatic Stress services nationally across Scotland.
- Set up and led Clinical Governance Structures across Combat Stress 2007-2020.
- I was Responsible Officer for Combat Stress as a Designated Body (2013-2020) registered with NHSE and the GMC; as Responsible Officer I ensured appropriate structures were in place for the appointment and appraisal and revalidation of doctors employed by Combat Stress in accordance with GMC and NHSE national Guidelines.
- Awarded National Specialised Commissioning (13 March 2011) from the NHS England (£20 million 2011-2018 to set up a six-week residential programme which I designed to treat 224 veterans per year suffering from severe and co-morbid presentations of PTSD across England.
- Awarded £1.2 million from NHS Scotland pa from 2010 (current) for provision of mental health services including a residential six-week treatment programme for treating severe PTSD to Scottish Veterans.
- In April 2013 my bids were awarded £2 million from LIBOR and £267,000 from the Scottish Lottery for the setting up of a Case Management Programme for Veterans suffering from Alcohol and Illicit Substance Misuse Disorders which comprised a multi-agency clinical pathway incorporating community alcohol and illicit drug case management service nationally.
- Developed further group programmes to address anger, domestic violence, chronic pain and PTSD, alcohol and drug misuse and PTSD. I have presented clinical, psychometric and audit findings to NHSE national specialist commissioners and Armed Forces Commissioners, commissioners from the Scottish Mental Health and to the clinical lead on veterans on Veterans.
- I have also helped to develop a wellbeing and rehabilitation clinical pathway.
- I have produced clinical strategy papers on the clinical management of alcohol and illicit drug use in veterans, Reservists, and also for the Al-Sweady military Enquiry which comprise self-help leaflets and directions for court officials as well as mapping a support and clinical pathway for vulnerable military and veteran witnesses.
- In my role as Director of Medical Services I liaised directly with Ministers and MPs as well as Scottish MEPs to shape national mental health services for Veterans including with the Prime Minister in August 2010.
- I gave evidence at the Defence Select Committee at Portcullis House on 24 April 2018 about the mental health needs of Veterans.
- I helped to set up a strategic partnership between the DoH and MOD with Combat Stress signed Jan 2010 and Feb 2013.
- Through my clinical strategy and my participation, I helped promote and raise £30 million launched by our Patron HRH the Prince of Wales on 12 March 2010. This Appeal called 'the Enemy Within' funded our national multidisciplinary clinical teams (14 clinical teams and further welfare professionals) working with Veterans who served in the Territorial Military services. This community service is based on my clinical strategy.
- I have worked with the DoH to set up the new Combat Stress national telephone help line in collaboration with 'Rethink' and more latterly Connect Assist. This help line has been widely accepted and now has taken around 20,000 calls annually.
- Helped to set up and support and evaluate six pilot NHS clinical services for Veterans funded by the MOD 2007-2010.



- Collaborated with the Royal British Legion, Help for Heroes, RAF Association, Soldiers Sailors Forces Association (SSAFA) and other national veterans' charities.
- Set up a Research Department at Combat Stress linked to the Kings Centre for Military Health Research
 headed by Professor Sir Simon Wessely President of the Royal College of Psychiatrists in 2014. Since its
 inception this department has published over 60 papers since 2014 in first class peer reviewed journals
 including the BMJ. I lead the research strategy and participate in internal, national and international
 research studies into veteran's mental illness including PTSD.
- I have worked in partnership with the NHS in England, Scotland and Wales and Northern Ireland, the Ministry of Defence the Royal British Legion and Help for Heroes.
- I regularly liaise on a national basis at the highest levels with the NHS, MOD, War Pensions; other charitable ex-servicemen's agencies, and nationally renowned research centres on a regular basis. I am helping to lead the development and upgrading of intervention protocols for veterans including PTSD nationally. I regularly see patients in clinic where I assess and treat patients. I am actively involved in research studies into veteran's mental illness including PTSD.
- While at the Dene I led the development of specialised services for women including an inpatient Personality Disorders & Trauma Unit for which I was lead clinician; a Psychosis Unit, an Intensive Care Unit & Rehabilitation Unit. The personality disorders unit treated women who were victims of multiple childhood traumas. Treatment approaches included a community therapeutic milieu incorporating principles of interactive psychoeducation, Dialectic Behaviour Therapy, psychodynamic therapy and trauma focussed cognitive behaviour therapy and eye movement desensitisation and reprocessing (EMDR). I was part of the Senior Management Team running the hospital that was expanded and which included the setting up of a low secure 21 bedded hospital. I reformed and lead clinical governance. I also reformed and line-managed the psychology and psychotherapies department.
- From November 1997 to September 2004 I set up and led a new unit at Ticehurst House Hospital for the treatment of victims of repeated psychological trauma and Complex PTSD using group psychotherapy, and cognitive techniques. Treatment outcomes were published in peer review literature.
- Masters Thesis (1995) in Psychology proposed the use of various psychological interventions for the prevention of Traumatic Stress Disorders in Emergency Workers and Military Organisations.
- Part of the RAF Traumatic Stress Disorders Team that treated the British hostages released from Lebanon in 1991 and the British prisoners of the Gulf War.
- Part of the RAF PTSD Unit which pioneered the use of new assessment techniques for the victims of traumatic stress, and the novel use of Group Therapy Techniques in the treatment of established Post Traumatic Stress Disorder 1990 - 1993. Outcome and assessment studies were published in peer review literature.
- Research in Post Traumatic Stress Disorders has resulted in around 75 peer reviewed academic publications: co-author and main author of several academic papers, articles, letters and eleven book chapters in leading psychological trauma American, British and Australian textbooks on PTSD and personality disorders.




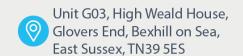
MEDIA WORK

- I am seen as a National and International expert in the field especially in relation to PTSD in veterans and military personnel and adult survivors of sexual abuse and their mental health.
- Media work has included filming on March 22nd 2021 with Anita Rani for a BBC TV programme on veterans' mental health; Invictus Games BBC with HRH Prince Harry 2016, Newsnight with Kirsty Wark in 2014, Documentary with Ross Kemp in 2013. PRIVATE PRACTICE AND MEDICO-LEGAL WORK:

Besides my Combat Stress job and Medicolegal work, I have a small private practice where I treat and supervise clinical cases as well as undertake Medico legal work. I routinely assess and treat patients suffering the effects of psychological trauma generated by road traffic accidents, interpersonal violence, accidents at work, disaster and conflict.

- Medico-legal Work 1991 present. Approximately 46-80 reports per year; 35% defence; 15% joint instructions; 50% claimant.
- Most reports and court work related to high value compensation cases for victims of traumatic stress: disasters, road traffic accidents, psychiatric effects of medical negligence. Class actions related to blue light services and disaster victims
