## **MEDICO-LEGAL**

I am regularly involved in assessing parenting issues in adults with mental health difficulties and addiction.

I have been involved in assessing a number of cases involving Munchausen syndrome. In addition adult ADHD/ Autism and functional neurological disorder.

I assess psychological injuries and have had 20 years of involvement in medico-legal assessments.

I have worked in immigration cases. I undertake criminal fitness to plead assessments for prosecution and defence cases-50%/50%.

I undertake instructions in clinical negligence and the impact of this psychologically.

My experience in assessing PTSD includes military settings (Gulf War, Northern Ireland, Bosnia and Far East Prisoners of War) Terrorist incidents, Clinical Negligence, and Accidents personal injury and occupational events.

I regularly undertake medical negligence cases for psychological/psychiatric injury assessment as a result of NHS care failings. I have undertaken 15 instructions on post surgical cases in 2012/2013. I have provided reports for claimants and NHS trusts.

I have considerable expertise on capacity assessments and formally undertake, for legal purposes 40 assessments per year on capacity.

#### **EXPERTISE IN PSYCHIATRY**


I sat on local trust committees for example drug and therapeutics which looks at interventions and risk issues in mental health.

I contribute to NHS local protocols and policy. I sit on two national committees setting the agenda for new innovations in primary care mental health and complex design interventions. I advise on US health policy mental health aspects through links to University Indiana health service research group examples include mental health screening.

I have broad experience in trauma assessments, anxiety disorders, psychosis and depression. I have 10 years of medico-legal reporting in this field.

I have undertaken numerous cases reporting on the impact of care home closures on the elderly as well as forensic reviews of government reports for court cases in this area.

#### **EXPERTISE IN ADDICTION**

I trained as a specialist in General Adult and Old Age Psychiatry. I spent a significant proportion of my training in assessing addiction cases in my work for the Ministry of defence.

I have experience of drug users has been through exposure as part of my General adult training as co-morbid. I am experienced on assessment and currently am often called to assess conditions which may or may not be related to substance misuse and to risk assess in the independent sector and NHS. I have been involved in methadone management in the past. I have expertise in assessing personality issues relevant to drugs. Currently aside from assessing cases in a medico legal setting in various age groups/ conditions e.g alcoholism- my day to day NHS work is with the elderly.

Until 2010 I lectured at degree level on the management of addictions in all forms at the University of Kent and was involved in training addiction counsellors-prison officers, social workers etc. I have recently moved to the University of East Anglia Medical School. I am reviewer for the international cochrane collaboration on alcohol. I have significant experience of appraising research evidence and in my practice adopts the latest research practice. I am currently collaborating on the assessment and managing anger and violence and applying such techniques from forensic mental health to challenging behaviour Inquests.




