Case versus secretary of state in twin child contaminated with HIV at birth due to alleged inappropriate "Ventouse" delivery twin sister HIV negative. Involved comparative Intelligence testing of both twins (WISC-IV, WIAT-II) and measure of existing mood utilising Beck Youth Inventories (BYI-II). Responsibility admitted ongoing discussion re compensation level.

Specialisation in medical negligence claims following cosmetic procedures.

Cases related to child custody and mental health of parent applicant utilising scientifically validated psychometric measures.
