EXPERT WITNESS AND MEDICO-LEGAL WORK

I have extensive experience as an expert witness in civil, criminal and family proceedings spanning over 15 years. I have been assisting Courts and Tribunals with written and oral expert evidence since 2005. I provide regular psychiatric expert reports on instructions of the defence, the prosecution and the Courts, including acting frequently as a single joint expert. I have wide experience in giving evidence in all types of courts, including remotely.

Civil Proceedings

I have extensive experience as an expert witness in cases of personal mental and psychological injury. I regularly provide expert reports on those who have suffered mental and psychological problems, such as Post-Traumatic Stress, Depressive and Anxiety Disorders, as a consequence of being exposed to traumas, accidents and/or abuse.

I regularly provide expert reports (condition and prognosis) on people who have been exposed to various accidents, including Road Traffic Accidents, accidents in the workplace, violent robberies, serious violence, torture, fires, serious abuse (physical, emotional and sexual), war disasters, bombings and explosions. I also regularly provide expert reports on those who have suffered traumatic experiences/mental injury due to medical negligence.

I have provided regular assessments of people with PTSD, Depression and Anxiety for 'The UK Criminal Injuries Compensation Authority' (CICA) which is the UK Government Agency dealing with compensation claims from people who have been mentally injured because they were victims of a violent crime.

I have also provided regular reports for 'The Centre for Health and Disability Assessments' on behalf of 'UK Veterans' and 'The Department for Work and Pensions'.

Criminal Proceedings

I regularly provide psychiatric expert reports for the purpose of criminal proceedings on defendants who are diagnosed with, or suspected to have, mental health problems/illnesses that may have affected their behaviour in relation to committing an offence. I regularly provide reports addressing the defendants' fitness to plea and stand trial, mens rea, capacity and state of mind at the time of offence, disposals, vulnerabilities and other relevant matters in these cases.



ECATT is a single point of access, ageless (18 y - no upper limit), borough-wide team with 3 functions:

- 1. Assessment function for all new referrals to Ealing Mental Health Service (~250 per month)
- 2. Brief Intervention Function aims to treat and discharge patients to primary care within 3 months
- 3. Crisis & Home Treatment Function (as per standard national criteria)


<u>Lead Consultant for Single Point of Access (SPA), West London NHS Trust (April 2016 – current)</u>

SPA is a trust-wide, 24 hours, triaging and crisis support team of clinicians and trained mental health advisors which manages all mental health referrals to West London NHS Trust (Hammersmith, Fulham, Hounslow and Ealing- about 900 referrals per month). It follows a robust clinical triage process and aims to respond within 4 hours in emergency and 24 hours in urgent cases. It also provides a telephone support and advice to patients and carers in crisis 24 hours a day.

My role involves working with 3 CCGs and 3 GP leads to improve quality of referrals from Primary to secondary care and reduce inappropriate referrals. Since April 2016, I have provided daily telephone advice to 450 GPs across the trust allowing GPs to manage increasing numbers of patients in primary care and reducing number of referrals needing to be taken on by the trust to 50%.

Mood Disorders (Bipolar Affective Disorders I & II & Depressive Disorders)

Over the last few years, I have gained wide recognition for my expertise in Mood Disorders at the local and national level.

In 2018, I was a member of a representative panel of national and international bipolar experts who produced the International Consensus Definition of Treatment-Resistant and Multi-Therapy-Resistant Criteria for Bipolar Depression, published in the British Journal of Psychiatry in January 2019.

In 2015, I was a member of 'UK Treatment-Resistant Depression Expert Forum' providing advice to independent organisations and appointed as Lead for the implementation of "Bipolar NICE Guidelines CG185" at West London trust.

I produced, with an internationally renowned Bipolar expert, the podcast on 'Challenges in Diagnosing Bipolar Disorder II' available on the Royal College of Psychiatrists' website and referenced in other websites such as the International Bipolar Foundation and Bipolar UK.


I was the Affective Disorders Lead at West London Trust for 4 years, during which I collaborated with a number of world leaders in Bipolar to integrate the latest evidence-based interventions in developing Bipolar Disorder Intergraded Care Pathway at the Trust.

I founded and ran a 'Specialist Mood Disorders Clinic' in Ealing for 7 years, diagnosing and treating patients with Bipolar Affective Disorders and offering second opinion for complex and treatment-resistant cases . The feedback from patients provided by the Royal College of Psychiatrists' 360 feedback ranked me in the top 10% of participating UK psychiatrists.

My expertise and high standard of care in treating Bipolar Disorders were publicly recognised by the chair of national bipolar disorder charity, MDF the Bipolar Organisation (Manic Depression Fellowship) in an article to fight stigma and also led to nomination for 'West London Quality Award - Service Users'

I led on a '12-week Bipolar Psychoeducation Group pilot' which was published in the Tavistock Psychotherapist Society magazine.

Adult Attention Deficit and Hyperactivity Disorder (ADHD)

I have developed special expertise in Adult ADHD, and acted as the lead for adult ADHD at Ealing, West London Trust for 5 years.

I established the first and only Specialist Adult ADHD Service at Ealing and ran it for 5 years providing specialist assessment, diagnosis and treatment for all adults referred to Ealing Mental Health Service seeking assessment for ADHD or further specialist treatment.

The success and popularity of this service led to a dramatic increase in number of referrals seeking ADHD/ ASD assessment, which in 2018 comprised 26% of all referrals to Ealing Adult Mental Health Service prompting the CCG to consider a separate business case for funding ADHD Service in Ealing.

PRIMARY CARE


I have worked very closely over the last 13 years with primary care/ CCG, developing clinical pathways & shared care protocols and delivering trainings to improve integrated care between primary & secondary care for a safe patient transition between the two systems. I developed the first *Ealing Adult Primary Care Strategy* and co-developed, with CNWL Trust, GP Training Modules approved by North-West London CCG to improve shared care& joint work with Primary care

I was the trust's lead on the *National Primary Care Collaborative* between 05- 07, trust's primary care lead between 07-11, deputy then senior clinical lead in Ealing between 2011-14 and trust's single point of access lead from 2016 – current. In each position I played the leading role in improving interface between primary / secondary care in Ealing, and more recently, Hounslow and Hammersmith & Fulham.

Since April 2016, I have been providing a daily telephone advice service to 450 GPs in West London Trust which reduced inappropriate referrals to secondary care including unnecessary use of A&E. I led on developing new 'Primary Care Referral Management Criteria' in Ealing with CCG leads.

I represented West London Trust in 'Early Adopter of Whole System Integrated Care Team, which developed the pioneer vision for the 'Whole Systems Integrated Care' in North West London to enhance care quality. I co-produced a new WSIC MDT model of care, presented it to an "External Advisory Panel" of notables from national & international health & social care experts.




