EXPERIENCE

I have worked at consultant level for the last 18 years and have considerable experience in the assessment and management of a **very broad range of psychiatric conditions**. In addition to my NHS work I regularly provide Expert Witness reports for a variety of legal settings.

My medicolegal experience dates back to my time as a trainee working in the Court Diversion Scheme based in Highbury Magistrates court, which would involve the assessment of patients and the same day preparation of court reports and the giving of evidence, if needed. I prepare reports and attend first tier Mental Health Tribunals on a weekly basis. I prepare on average 25 reports a year for Criminal/Family and Civil settings.

I've attended Bond Solan training in the preparation of medico-legal reports (2021). I've recently attended Royal college of Psychiatrists training in the preparation of medicolegal reports (December 2020).

Since my appointment as a consultant in 2004, I have prepared reports for:

Magistrates and Crown court cases, issues of fitness to plead and disposal.


