### MEDICO-LEGAL EXPERIENCE

I have been acting as an Expert for over 35 years. I have received training in report writing, appearing in Court and acting as a Single Joint Expert. I have given evidence in the Family, Civil and Criminal Courts including the Central Criminal Court and the Royal Courts of Justice as well as at Tribunals. My fields of expertise include post-traumatic stress disorder, personal injury, psychosis, affective disorders addictive behaviour, psychiatric assessment, criminal responsibility, fitness to plead, witness assessment, mental disorders, dangerousness and Mental Health Act reviews.

### Family Court Proceedings

I have extensive experience in providing expert evidence for the Family Courts over the last 30 years. I regularly prepare reports for Family Court Proceedings and have given Oral Evidence. I regularly assess individuals to determine whether they have a mental illness or personality disorder, and if either are present any impact on their parenting abilities. I also assess individuals for their use of alcohol and illicit substances and any impact on their parenting ability.

### Criminal Proceedings

I have been preparing reports in Criminal Proceedings for over 30 years. I have been instructed by the CPS and by the defence. I regularly assess fitness to plead and stand trial, capacity to form intent and diminished reasonability. I have acted as an expert for cases including murder and appeared as an expert in the Old Bailey.

### Civil Proceedings

I have extensive experience in acting as an expert both for the claimant and defendant in civil proceeding. This includes personal injury and medical negligence claims. This includes determining any injury, causation, prognosis and likely response to any treatments available and time scales.

### Other Proceedings

I prepare reports for other proceedings including immigration and Employment Tribunals. I also act as an Expert for hearings before Professional Bodies and Regulators and have been instructed by various Bodies including the Bar Standards Board, The GDC and NMC.

## PSYCHIATRIC CAREER

I completed my General and Higher Psychiatric Training at St Georges Hospital Medical School and the SouthWest Thames rotational training schemes. I spent 2 years as a research fellow at the Medical School.

In 1994 I was appointed as a Consultant Psychiatrist at the Royal London Hospital. I worked across inpatient and Community services in East London for 25 years. I held various Senior Management positions there including being a Clinical Director, Associate Medical Director and the Medical Director. In 2019 I was seconded to the Norfolk and Suffolk NHS Trust as part of the East London support package as a Medical Director. I am currently the Medical Director for Workforce at NSFT.

I have been involved in the Service Design and implementation across a wide range of Services. I have extensive experience of working across the range of community, inpatient and specialist services. I have frequently been asked to review and help resolve complex issues presenting to Clinicians and Clinical services.
